to discharge him from a residential health : care facility.

Beth Abraham Health Center ("Facility") issued a Notice of Transfer/Discharge, dated , 2017, to ("Resident"). The Resident appealed the Facility's proposed discharge. On December 8, 2017, a hearing was held before WILLIAM J. LYNCH, ESQ., ADMINISTRATIVE LAW JUDGE.

The hearing was held in accordance with the Public Health Law of the State of New York; Part 415 in Volume 10 of the Official Compilation of Codes, Rules and Regulations of the State of New York ("NYCRR"); Part 483 of the United States Code of Federal Regulations ("CFR"); the New York State Administrative Procedure Act ("SAPA"); and 10 NYCRR Part 51.

Evidence was received and witnesses were examined. An audio recording of the proceeding was made. The hearing was held at the

Facility located at 612 Allerton Avenue, Bronx, New York. The following individuals were present for the hearing:

Resident; Allison Bellin, Director of Social Work; Jose Santos, Social Worker; and Hyacinth Payne, R.N., Unit Nurse.

STATEMENT OF THE CASE

The Facility issued a determination proposing to discharge , 2017. The stated reason for the Resident effective the Resident's health had improved the discharge was that sufficiently so that he no longer required the services provided by a skilled nursing facility. The proposed discharge location was Shelter, the Resident filed a timely request for an appeal of the discharge the Facility pending decision and has remained in determination.

STATEMENT OF ISSUES

The issues to be determined in this proceeding are whether the Facility has established a basis which permits the Resident's discharge from the Facility and whether the proposed discharge plan is appropriate. The Facility has the burden of proving its

case by substantial evidence (10 NYCRR § 415.3[h][2][iii], SAPA § 306[1]).

FINDINGS OF FACT

The following Findings of Fact were made after a review of the entire record in this matter. Citations in parentheses refer to testimony or exhibits. These citations represent evidence found persuasive in arriving at a particular finding. Conflicting evidence, if any, was considered and rejected in favor of the cited evidence.

- 2. The Resident completed a program of physical therapy on 2017. Although he has from a history of a years ago, he ambulates independently with a and can perform all activities of daily living. (Facility Ex. 4; Recording @ 18:45).
- 3. The Resident can receive this same care as an outpatient and can manage his own medications. (Recording @ 12:50).

- 4. The Facility's interdisciplinary care team determined that the Resident no longer required skilled nursing services and could safely be discharged. (Facility Ex. 3; Recording @ 24:00).
- 5. The Resident's attending physician determined that the Resident was clinically stable to be discharged to the Shelter. (Facility Ex. 2).
- 6. On , 2017, the Facility issued a discharge notice to the Resident which proposed discharge to Shelter in (Facility Ex. 1).

ANALYSIS AND CONCLUSIONS

A resident may only be discharged pursuant to specific provisions of the Department of Health Rules and Regulations (10 NYCRR 415.3[h][1]). The Facility alleged that the Resident's discharge is permissible pursuant to 10 NYCRR 415(h)(1)(i)(a)(2), which states:

The transfer or discharge is appropriate because the resident's health has improved sufficiently so the resident no longer needs the services provided by the facility.

The Facility established through testimony and documents that there is no reason for the Resident to remain in a skilled nursing facility and that the Resident's medical conditions can be managed on an outpatient basis. After completing a program of

rehabilitation, the Resident can ambulate with a and independently perform all activities of daily living.

The Resident stated that he had a and spent some time in a nursing home when he was discharged from the hospital years ago, but the nursing home did not do enough rehabilitation for him so he has During the past years, the Resident explained that he lived with a in and then moved to He stated that he could not live with any family members or friends in so he stayed at the Shelter. The Resident now wants to remain in the Facility to receive additional rehabilitation services that he did not receive at the time of his years ago.

Based upon the evidence produced at the hearing, I find that the Resident no longer needs to reside in a skilled nursing facility and that he can obtain any required follow-up medical care on an outpatient basis while living at Shelter. The Facility provided sufficient rehabilitation to restore the Resident so he can again ambulate with a and perform his activities of daily living which was the goal set for his stay at the Facility. The Facility's discharge plan includes providing medications, follow-up instructions and transportation.

DECISION AND ORDER

- 1. The Facility is authorized to discharge the Resident in accordance with its discharge plan.
- 2. This decision may be appealed to a court of competent jurisdiction pursuant to Article 78 of the New York Civil Practice Law and Rules (CPLR).
