Overview of the NYS Viral Hepatitis Strategic Plan

Viral hepatitis continues to be a public health priority that requires the concerted efforts of individuals, agencies, and organizations at all levels and in every community.

The Viral Hepatitis Strategic Plan provides a framework to maximize the effectiveness of the work of a diverse array of partners engaged in fighting viral hepatitis in NYS. The framework is comprised of five focus areas with wide-ranging goals and strategies necessary for a comprehensive approach. The framework offers flexibility to meet a variety of needs, offering users latitude and options for action. The framework is intended to be user-friendly and engaging. The plan will be reviewed on an annual basis and updated if necessary.

The success of the Plan will involve a coordinated, collaborative, and sustained approach for viral hepatitis prevention, education, surveillance and research, medical care and treatment and policy and planning. The New York State Department of Health (NYSDOH) will engage and facilitate the involvement of others in carrying out the necessary activities to achieve the Viral Hepatitis Strategic Plan's goals and strategies. By aligning activities with the Viral Hepatitis Strategic Plan, the NYSDOH and others will maximize opportunities to eliminate new hepatitis A, B and C infections and improve the quality of life for individuals living with chronic hepatitis B and C.
