History

Definition:

 Hospital-sponsored Off-Campus Emergency Department means an Article 28 emergency department that is owned by a general hospital and geographically removed from the general hospital's inpatient campus.

History & Reason for:

- Increase the availability of emergency care in more convenient and readily accessible settings.
- Relieve overcrowding of hospital-based emergency departments.
- Operate with faster throughput, resulting in reduced patient wait times and increased patient satisfaction.
- More economical and efficient than constructing new hospitals.
- Fill health care voids in under-served regions.



New York State Law

 New York State allowed for the operation of hospitalsponsored Off-Campus Emergency Department's (OCED) and relied on Centers for Medicare & Medicaid Services (CMS) and existing state regulations to govern ownership and operation.

Regulatory Modernization Initiative (RMI) in 2017.



Regulatory Modernization Initiative (RMI) Workgroup

- Originally intended to provide emergency medical services in rural communities where there were no acute care hospitals and the distance to travel to an emergency department was too great.
- Expansion into urban and suburban areas where population rapidly expanded.



Regulatory Modernization Initiative (RMI) Workgroup Recommendations:

- New York State should continue to allow only those Off-Campus Emergency Departments affiliated with a hospital or hospital system.
- Not necessary to create a new need methodology.
- Demonstrate need for services, value to community, impact on surrounding emergency departments.
- Allow flexibility to account for unique local factors in the decision-making process.
