El-Hub Bootcamp Training Program


In response to feedback from stakeholders throughout New York State, the Bureau and Public Consulting Group are pleased to offer a new training experience for the El-Hub, called the El-Hub Bootcamp. The bootcamp training program is planned for a total of 6 weeks of direct engagement taking place over a three-month period. Training opportunities include:

- Topical (live and recorded) webinar sessions
- Virtual in-depth breakout sessions
- Office hours with Public Consulting Group trainers
- Continued support through the Public Consulting Group Call Center

The program will offer practical guidance on navigating a child through the Early Intervention Program stages using the EI-Hub.



Webinars



Break-out Sessions




Break-out sessions will provide additional instruction, in a small group setting, concentrating on difficult and deeper training needs identified during webinars.

 sessions.




Office Hours



Topical Areas

- ✓ 11/13: User Roles, Role Administrators, and Provider Management (provider re-approvals and amendments)

The El-Hub Bootcamp training program does not cover billing and claiming using third-party systems. Testing of 837P files within the El-Hub is scheduled to take place as part of the Provider Claims Loader Testing phase.



EI-Hub System Testing

Starting early 2024, the Bureau of Early Intervention/Public Consulting Group/New York State Technology Enterprise Corporation will start User Acceptance Testing with a small group of municipal and provider users. Testers will use migrated data from New York Early Intervention System and navigate a child through the Early Intervention Program stages to ensure the system is functioning as expected.

Insights gained from this testing phase will also benefit subsequent testers during statewide User Acceptance Testing.



Provider Claims Loader Testing

This testing is designed for providers/municipalities using **third-party billing systems**. Participants will test 837P file submission into the EI-Hub using real child data and receive 999 and 277 responses files indicating if their claims were accepted or rejected.

Testing is scheduled to begin **early 2024** and will continue for several weeks until all participants have had an opportunity to complete their test.

The Public Consultant Group has completed preliminary testing with third-party vendors to help ensure file format compatibility.
