#### Breakout 1: Opioid treatment programs, an opportunity to increase access to hepatitis C services

To achieve elimination in New York State, hepatitis C prevention, testing and treatment must be more accessible to people who use drugs. Opioid treatment programs are uniquely positioned to reduce access related barriers to hepatitis C services, including patient education and screening, medication delivery and storage, and treatment adherence. This session will review promising practices and lessons learned from three opioid treatment programs.

#### Breakout 2: Promising practices for hepatitis C screening and linkage to care in correctional settings

Nearly one-third of Americans with hepatitis C spend at least part of the year in a carceral facility. People who are incarcerated often have low rates of engagement with healthcare despite higher rates of significant health and behavioral health needs. Local jails and alternatives to incarceration programs are uniquely positioned to facilitate screening and address barriers to linkage to care for people with hepatitis C. This session will share lessons learned and promising practices for developing hepatitis C services in correctional settings.

## **Speakers**



#### Joseph Kerwin Director, AIDS Institute – New York State Department of Health

Effective March 16, 2023, Mr. Joseph Kerwin has been appointed Director of the AIDS Institute. Prior to serving as Director, Mr. Kerwin was a Deputy Director within the AIDS Institute for four years. His portfolio as a Deputy Director progressively expanded over the past four years to include oversight of the AIDS Institute's Health Care Programs, Uninsured Care Program, Medicaid Programs and Health Care Financing. Mr. Kerwin has been with the AIDS Institute for more than ten years. Prior to joining the AIDS Institute, Joseph was the Executive Director of AIDS Services at Catholic Charities and the Program Administrator of the AIDS Program and Division of HIV Medicine at Albany Medical Center.

Mr. Kerwin is responsible for the day-to-day decision making and operations of the AIDS Institute and has represented the AIDS Institute within the DOH, across state agencies and New York State. Priority efforts have focused on the integration of health equity principles to advance ending the epidemics of HIV, Hepatitis C, Congenital Syphilis, and opioid overdose, advancing LGBTQ+ health and wellness, and leading in many areas of the state's outbreak responses including COVID-19 and mpox.



#### Tina Kim, MSc

## Acting Deputy Commissioner for the Office of Health Equity and Human Rights of the New York State Department of Health

Tina Kim is the Acting Deputy Commissioner for the Office of Health Equity and Human Rights (OHEHR) at the New York State Department of Health. Tina oversees day-to-day operations and is responsible for developing, shaping, and implementing policies and programs advancing health equity and related to diversity, equity and inclusion (DEI). OHEHR leads New York State Department of Health's commitment and strategy to be a diverse, anti-racist, equitable and inclusive organization.

Tina formerly served as Assistant Secretary for Health for the State of New York. Within the Governor's State Operations Office, Tina developed and implemented cross-cutting, statewide public health and health care initiatives and strategies. Before joining state service, Tina was Chief of Staff for the Deputy Executive Director leading the nation's largest COVID-19 testing and contact tracing operation. She also served as Senior Advisor for Health Care Delivery in the New York City Mayor's Office. Before the COVID-19 pandemic, Tina helped design and launch NYC's Guaranteed Care initiative, which includes the NYC Care health care program for the uninsured. She also designed initiatives involving cross-agency collaboration, most notably the Asthma-Free Bronx program to address pediatric asthma in the Bronx.

Tina has worked in policy roles for the New York City Department of Health and Mental Hygiene, the Community Clinic Association of Los Angeles County, the Gates Foundation, Asian and Pacific Islander Health Forum and the San Francisco Department of Public Health. Tina holds a Master's of Science in Public Health degree from the Johns Hopkins Bloomberg School of Public Health and a Bachelor's degree from the University of California, Los Angeles.

#### **Ashwin Vasan, MD, PhD** 44<sup>th</sup> Commissioner of Health, City of New York

Dr. Ashwin Vasan is the 44th Health Commissioner of New York City. He is a practicing primary care physician, epidemiologist and public health expert with nearly 20 years of experience working to improve physical and mental health, social welfare and public policy outcomes for marginalized populations in New York City, nationally and globally.

In his role as Commissioner since early 2022, Dr. Vasan has reshaped the city's public health system to focus on addressing the main drivers of declining life expectancy in the post-COVID emergency era, including overdoses, chronic and diet-related diseases, birth inequities, climate change, and gun violence, while simultaneously strengthening the Health Department's emergency response-readiness capacities. Throughout this work, he has brought in a unique, unparalleled focus to combating the mental health crisis, releasing a comprehensive citywide mental health plan addressing the second pandemic - a crisis of mental health plaguing youth, vulnerable New Yorkers with severe mental illness, and those impacted by the overdose epidemic. Dr. Vasan has concurrently led several other key health priorities, such as the launch of HealthyNYC, a campaign to reverse the downward trend in life expectancy, launch of TeenSpace among other social media efforts to combat the negative impact of social media on kids' mental health. He also led the ongoing response to COVID-19 as the first American jurisdiction to kickstart vaccination efforts, combatting the 2022 mpox outbreak and pioneering readiness and response to the first case of polio in the US in a decade. Under his leadership, the city also took charge on protecting reproductive rights by launching the NYC Abortion Access Hub, connecting people from New York and nationwide to providers and becoming the first jurisdiction in the US to offer free medication abortions in its clinics. Recently, under his leadership, the Health Department launched a historic debt relief initiative to purchase and cancel medical debt for half a million New Yorkers.

Having begun his career in global health working at Partners in Health and the HIV Department of the World Health Organization, he most recently served as the President and CEO of Fountain House, a US-based mental health nonprofit. He currently serves as faculty at the Columbia University Mailman School of Public Health and Vagelos College of Physicians and Surgeons.

Dr. Vasan received his BA in Economics from the University of California, Los Angeles; his ScM in Epidemiology from the Harvard School of Public Health; his MD from the University of Michigan; and his PhD in Public Health from the London School of Hygiene and Tropical Medicine. He completed his clinical training in internal medicine-primary care at New York Presbyterian Hospital.





#### **Dr. Rachael L. Fleurence, PhD, MSc** Senior Advisor, National Institutes of Health

Dr. Fleurence is a Senior Advisor to Dr. Francis Collins at the National Institutes of Health where her work is focused on launching a national initiative to eliminate Hepatitis C. Previously, Dr. Fleurence served as a senior health policy advisor in the Biden-Harris White House. Prior to her role at the White House, Dr. Fleurence served as Senior Advisor to the NIH Director at the NIH. As part of the federal response to COVID-19, Dr. Fleurence led the novel "Say Yes! Covid Test". This program was the first of its kind in to provide free rapid antigen tests to over 7 million Americans. Dr. Fleurence served on the White House Pandemic Testing Board policy group, and the White House Office of Science Technology Policy (OSTP) Pandemic Innovation Task Force in 2021-2022. In 2021 and 2022, Dr. Fleurence was a recipient of three NIH Director's Award for exceptional dedication and innovation in advancing COVID-19 testing and diagnostics efforts. In 2022, Dr. Fleurence was a recipient of the Health and Human Services Secretary's award for Distinguished Service.

Prior to her role at the White House and NIH, Dr. Fleurence served as the Executive Director of the National Evaluation System for health Technology Coordinating Center (NESTcc), and served as the Program Director for PCORnet at the US Patient-Centered Outcomes Research Institute (PCORI). Dr. Fleurence received a BA from Cambridge University (United Kingdom), an MA in business management from ESSEC-Paris (France), and an MSc in health economics and PhD in health sciences, both from the University of York (United Kingdom).



#### Larissa Wilberschied, MS Program Manager, Bureau of Hepatitis Health Care and Epidemiology, AIDS Institute – New York State Department of Health

Larissa Wilberschied, MS, is a Program Manager in the New York State Department of Health, Bureau of Hepatitis Health Care and Epidemiology. She has 20+ years of experience in public health: including hepatitis C, tuberculosis, HIV, substance use, and communicable disease epidemiology. She was a member of the New York State Hepatitis C Elimination Surveillance, Data, and Metrics Workgroup and is involved with the development and tracking of the primary hepatitis C elimination metrics.

#### **Colleen Flanigan, RN, MS** Director, Bureau of Hepatitis Health Care and Epidemiology AIDS Institute – New York State Department of Health

Colleen Flanigan currently serves as the Director of the Bureau of Hepatitis Health Care and Epidemiology at the New York State Department of Health AIDS Institute. Ms. Flanigan has been involved in hepatitis C related work for two decades. She directs the hepatitis C programmatic and policy work and the hepatitis B and C surveillance activities for New York State. Ms. Flanigan is also responsible for the implementation and monitoring of the New Yorks State Hepatitis C Elimination Plan. Ms. Flanigan holds a Bachelor's degree in Biology and a Master's degree in Nursing.

Holly Anger is a Senior Surveillance and Research Scientist at the New York City Department of Health where she conducts and oversees analysis projects related to the epidemiology of hepatitis B and C. She has over 18 years of experience working in public health in both international and domestic settings. Holly received her Master's in Public Health from Columbia University and is currently a 4th year PhD student in Epidemiology at the CUNY School of Public Health and Health Policy.



#### Marie P Bresnahan, MPH

## Director of Training, Policy and Administration, Viral Hepatitis Program, Bureau of Hepatitis, HIV and STI, NYC Department of Health and Mental Hygiene

Marie Bresnahan has worked in the Viral Hepatitis Program at the NYC Department of Health and Mental Hygiene since 2014. She works on viral hepatitis policy issues, she leads training initiatives and supports administrative activities in the program. Before that, she led Project INSPRIRE which was a CMS-funded Health Care Innovation Award designed to implement an innovative care model for hepatitis C. Marie worked previously at the American Liver Foundation and was a founding member of the National Viral Hepatitis Roundtable (NVHR). Her prior experience includes working at the Advisory Board Company, the U.S Fund for UNICEF and at Covenant House. Marie has a Master's in Public Health from the City University of New York, Graduate School of Public Health and Public Policy and an undergraduate degree from Russell Sage College.

#### **Ana Ventuneac, PhD** Vice President of Research and Evaluation, START Treatment & Recovery Centers

Ana Ventuneac, PhD is Vice President of Research and Evaluation at START Treatment & Recovery Centers where she leads research on integrated services for infectious diseases and substance use disorders in an outpatient treatment program for opioid use disorders. Dr. Ventuneac has a broad background in public health and health services research. #### Anthony McLeod Program Manager, START Treatment & Recovery Centers


Anthony McLeod is Program Manager at START Treatment & Recovery Centers where he leads three priority projects in addressing access-related barriers to highly effective medications to eliminate Hepatitis C in communities most impacted by the opioid crisis and hepatitis C infection. In collaboration with Dr. Andrew Talal, University at Buffalo, with funding from PCORI, he contributed to the development of a facilitated telemedicine model to integrate treatment services for hepatitis C with treatment for opioid use disorder. Additionally, with funding from the NYC Department of Health and Mental Hygiene Viral Hepatitis Program, he established capacities for integrated HCV treatment onsite at START to promote low-barrier access to treatment services. Currently, with funding from the AIDS Institute, New York State Department of Health, he leads a team of patient health navigators to expand prevention and treatment services for viral hepatitis.





#### **Antonie Hiemer, PhD, MS, RN, CLNC** Madison County Sheriff Department

Antonie Hiemer has served as the Supervising Jail Nurse at Madison County Sheriff Department since 2018. She has been instrumental in establishing an opt-out hepatitis C testing pilot program within the jail.
