# NYSDOH STATEWIDE MOSQUITO-BORNE DISEASE ACTIVITY REPORT December 22, 2022

The New York State Department of Health (NYSDOH) collects, compiles, and analyzes information on mosquito-borne disease activity in New York State (NYS) and produces this weekly report. Data in this report reflects testing performed by both NYSDOH's Wadsworth Center Laboratories (WC) and the New York City Department of Health and Mental Hygiene's (NYCDOHMH) Public Health Laboratory (PHL).

# Weekly Summary (October 02 - October 08)

#### WNV:

- 4 WNV-positive pools have been identified in NYS, outside of NYC. (Nassau 3, Suffolk 1)
- WNV-positive mosquito activity has been reported in 4 NYC counties. (Bronx, New York, Queens, Richmond)
- o 6 human cases of WNV infection have been reported, outside of NYC. (Nassau 3, Suffolk 2, Westchester 1)
- 0 equine cases of WNV infection have been reported.
- 0 presumptive viremic donors have been reported, outside of NYC.<sup>1</sup>

#### EEE:

- 1 EEE-positive mosquito pool has been identified. (Onondaga 1)
- 0 human cases of EEEV infection have been reported.
- 0 equine cases of EEEV infection have been reported.
- 0 caprine cases of EEEV infection have been reported.<sup>2</sup>
- 0 ratite cases of EEEV infection have been reported.3

#### ZIKV:

- Aedes albopictus has been identified in 0 additional counties outside of NYC. Aedes aegypti has not been identified anywhere in the state.
- 0 mosquito pools have been positive for Zika virus.
- 0 human cases of ZIKV infection have been reported to NYSDOH. No cases of local mosquito-borne transmission (LMBT) have been identified.<sup>4</sup>
- CHIKV, DENV, and Malaria<sup>5</sup>:
  - 0 human cases of CHIKV infection have been reported to NYSDOH. 0 cases of LMBT have been identified.
  - 0 human cases of DENV infection have been reported to NYSDOH. 0 cases of LMBT have been identified.
  - 2 human cases of malaria infection have been reported to NYSDOH (Monroe 1, Nassau 1). 0 cases of LMBT have been identified.

# Year to Date Summary (01/01/2022 - 10/08/2022)

#### WNV:

- 333 WNV-positive pools have been identified in NYS, outside of NYC.
- WNV-positive mosquito activity has been reported in 5 NYC counties. (Bronx, New York, Queens, Richmond, Kings)
- 38 human cases of WNV infection have been reported, outside of NYC.
- 0 equine cases of WNV infection have been reported.
- 5 presumptive viremic donors have been reported, outside of NYC.<sup>1</sup>

#### EEE:

- 22 EEE-positive mosquito pools have been identified.
- 0 human cases of EEEV infection have been reported.
- 5 equine cases of EEEV infection have been reported.
- 0 caprine cases of EEEV infection have been reported.<sup>2</sup>
- 0 ratite cases of EEEV infection have been reported.<sup>3</sup>

#### ZIKV:

- Aedes albopictus has been identified in 3 counties outside of NYC. Aedes aegypti has not been identified anywhere in the state.
- 0 mosquito pools have been positive for Zika virus.
- 1 human case of ZIKV infection has been reported to NYSDOH. No cases of local mosquito-borne transmission (LMBT) have been identified.<sup>4</sup>
- CHIKV, DENV, and Malaria<sup>5</sup>:
  - 3 human cases of CHIKV infection have been reported to NYSDOH. 0 cases of LMBT have been identified.
  - 15 human cases of DENV infection have been reported to NYSDOH. 0 cases of LMBT have been identified.
  - 40 human cases of malaria infection have been reported to NYSDOH. 0 cases of LMBT have been identified.

<sup>&</sup>lt;sup>1</sup> Presumptive viremic donors (PVDs) are people who had no symptoms at the time of donating blood (people with symptoms are deferred from donating) through a blood collection agency, but whose blood tested positive in preliminary tests when screened for the presence of West Nile virus. Some PVDs do go on to develop symptoms after donation, at which point they would be included in the count of human disease cases by their state.



<sup>&</sup>lt;sup>4</sup> Local mosquito-borne transmission is defined by the absence of the following epidemiological risk factors: recent travel to a country or region with known active ZIKV transmission OR sexual contact with a recent traveler from these areas; recent blood transfusion; recent laboratory exposure to ZIKV; or mother-to-child transmission during pregnancy. NYCDOHMH directly reports human cases of ZIKv infection to CDC.



### 2022 Eastern Equine Encephalitis Virus Surveillance Summary



### 2022 Aedes aegypti/albopictus Surveillance Summary








Fig 1. Current year and trend data for human WNV cases (excluding NYC)




Fig 2. Current year and trend data for human EEE cases (excluding NYC)




Fig 3. Weekly summary of West Nile Virus positivity by mosquito species. Numbers within each bar represent the number of total pools tested.




Fig 4. Year-to-date summary of West Nile Virus positivity by mosquito species. Numbers within each bar represent the number of total pools tested.




Fig 5. Weekly summary of Eastern Equine Encephalitis positivity by mosquito species. Numbers within each bar represent the number of total pools tested.




Fig 6. Year-to-date summary of Eastern Equine Encephalitis Virus positivity by mosquito species. Numbers within each bar represent the number of total pools tested.

### Seasonality of Human Cases




Fig 7. Seasonal patterns of human vector-borne disease cases (excluding NYC)
