NYSDOH STATEWIDE MOSQUITO-BORNE DISEASE ACTIVITY REPORT August 29, 2024

The New York State Department of Health (NYSDOH) collects, compiles, and analyzes information on mosquito-borne disease activity in New York State (NYS) and produces this weekly report. Data in this report reflects testing performed by both NYSDOH's Wadsworth Center Laboratories and the New York City Department of Health and Mental Hygiene's (NYCDOHMH) Public Health Laboratory.

Weekly Summary (August 18 - August 24)

- West Nile Virus (WNV):
 - 56 WNV-positive mosquito pools¹ have been identified in NYS, outside of NYC².
 - Chautauqua 1, Erie 2, Madison 1, Nassau 8, Onondaga 1, Oswego 5, Rockland 19, Suffolk 18,
 Westchester 1
 - WNV-positive mosquito pools have been reported from 5 NYC counties in the previous two weeks.
 - New York, Richmond, Bronx, Queens, Kings
 - o 7 human cases of WNV infection have been reported, outside of NYC. Nassau 2, Suffolk 4, Westchester 1
 - 0 equine cases of WNV infection have been reported.
 - 1 presumptive viremic donor³ has been reported, outside of NYC. **Suffolk 1**
- Eastern Equine Encephalitis Virus (EEEV):
 - 4 EEEV-positive mosquito pools have been identified. Onondaga 1, Oswego 3
 - 0 human cases of EEEV infection have been reported.
 - 2 equine cases of EEEV infection have been reported.
 - Clinton 1, Franklin 1
 - 0 caprine cases of EEEV infection have been reported.
 - 0 ratite cases of EEEV infection have been reported.
- Chikungunya Virus (CHIKV), Dengue Virus (DENV), Zika Virus (ZIKV), and Malaria⁴:
 - 0 human cases of CHIKV infection have been reported. 0 cases of local mosquito-borne transmission⁵ (LMBT) have been identified.
 - 2 human cases of DENV infection have been reported. 0 cases of LMBT have been identified.
 - 0 human cases of ZIKV infection have been reported. 0 cases of LMBT have been identified.
 - 1 human case of malaria infection has been reported. 0 cases of LMBT have been identified.

¹ Mosquitos collected by county surveillance staff are grouped into one or more "pools" of specimens based on date, location, and species. A positive pool refers to one in which at least one specimen was positive for a given pathogen.

Year to Date Summary (01/01/2024 - 08/24/2024)

- West Nile Virus (WNV):
 - 455 WNV-positive mosquito pools¹ have been identified in NYS, outside of NYC².
 - 1413 WNV-positive mosquito pools have been reported from NYC counties.
 - 10 human cases of WNV infection have been reported, outside of NYC.
 - 10 human cases of WNV infection have been reported in NYC.
 - 1 equine case of WNV infection has been reported.
 - 4 presumptive viremic donors³ have been reported, outside of NYC.
 - 3 presumptive viremic donors have been reported in NYC counties.
- Eastern Equine Encephalitis Virus (EEEV):
 - 19 EEEV-positive mosquito pools have been identified.
 - 0 human cases of EEEV infection have been reported.
 - 14 equine cases of EEEV infection have been reported.
 - 0 caprine cases of EEEV infection have been reported.
 - 0 ratite cases of EEEV infection have been reported.
- Chikungunya Virus (CHIKV), Dengue Virus (DENV), Zika Virus (ZIKV), and Malaria⁴:
 - 0 human cases of CHIKV infection have been reported. 0 cases of local mosquito-borne transmission⁵
 (LMBT) have been identified.
 - o 69 human cases of DENV infection have been reported. 0 cases of LMBT have been identified.
 - 41 human cases of malaria infection have been reported. 0 cases of LMBT have been identified.
 - o 0 human cases of ZIKV infection have been reported. 0 cases of LMBT have been identified.
 - Aedes albopictus is considered established in 5 counties outside of NYC. Aedes aegypti has not been
 identified anywhere in the state. Refer to the map on page 6 of this report for details regarding their currently
 documented range in NYS.












Fig 1. Current year and trend data for human WNV cases (excluding NYC). Trend lines are plotted with a LOESS smoother for comparison of the current year to the previous 3-yr average and should not be used to discern exact case numbers for a given week.




Fig 2. Current year and trend data for human EEE cases (excluding NYC). Trend lines are plotted with a LOESS smoother for comparison of the current year to the previous 3-yr average and should not be used to discern exact case numbers for a given week.

West Nile Virus Mosquito Pool Positivity by Species




Fig 3. Weekly summary of West Nile virus positivity by mosquito species. Numbers within each bar represent the number of total pools tested.




Fig 4. Year-to-date summary of West Nile virus positivity by mosquito species. Numbers within each bar represent the number of total pools tested.

Eastern Equine Encephalitis Mosquito Pool Positivity by Species




Fig 5. Weekly summary of eastern equine encephalitis virus positivity by mosquito species. Numbers within each bar represent the number of total pools tested.




Fig 6. Year-to-date summary of eastern equine encephalitis virus positivity by mosquito species. Numbers within each bar represent the number of total pools tested.

Seasonality of Human Cases




Fig 7. Seasonal patterns of human vector-borne disease cases (excluding NYC)
