 - S3526 and A6211 a bill to insure that responding ambulance service companies receive direct payment for all emergency ambulance service transports for the responding ambulance company upon submission of an invoice to the insurance company without the need for the responding ambulance company to become a preferred provider.
 - S8041 - A10172 An act to amend the workers compensation law for volunteer fire and volunteer ambulance in relation to COVID-19 exposures during a state of emergency.
 - S8650 - A10689 COVID-19 Hero's Loan Forgiveness Program.
 - S8579 - A10601 Diversity Training - EMS and SEMSCO is listed on 2-C and it may seem appropriate this bill be referred to Education and Training for review and consideration.
 - A10629 - An act to amend the mental hygiene law, in relation to establishing the frontline workers trauma informed care advisory council. This bill has passed - we should watch to see if the Governor signs it.
