**Management and staff reached consensus on the staffing levels for Interventional Radiology**

The Personalized Recovery Oriented Services (PROS) program provides an intensive group-based daily program for people with serious mental health challenges, which consists of up to 5 hours and 250 total services/day, for approximately 240 unduplicated patients/year. The program focuses on helping patients achieve self-defined, community based recovery goals through effective symptom management and robust psychosocial and vocational supports. In addition to an intensive array of group services that are regularly redesigned to best meet identified needs, medication management, individual therapy, collateral support, health screening, and linkages to outside medical and other adjunct services are also provided. Additional personnel supporting the RNs on the units include a Director, MH Counselor, MH Therapist, Peer specialist, Vocational Counselor and Office Support

**Management and staff reached consensus on the staffing levels for Outpatient Mental Health Services**

The Outpatient Mental Health Services (OMHS) program provides clinic-level behavioral health treatment for close to 2500 unduplicated patients/year, with a diverse array of diagnoses. This includes approximately 175 services/day for children, adolescents, and adults, which is comprised of individual, group, and family therapy, medication management, including long acting injections, as well as primary care health screening, linkages to appropriate medical services, and care navigation services to address patients' with more complex co-occurring substance use and health related social needs.

Additional personnel supporting the RNs on the units include a Director, Clinical Coordinator, Psychiatrist, Therapist, Nurse Practitioner, QI/Data Analytics, Care Navigators, Peer Specialists and office support. Staffing levels that are presented per shift are not intended to be at all times.

**Management and staff reached consensus on the staffing levels for the ECT program**

The ECT Service is located at the St. Vincent's campus. ECT is an effective treatment for major depression severe catatonia, acute mania and severe psychosis.

ECT is done on Monday- Wednesday-Friday mornings.

The service is comprised of a patient waiting area, a treatment room and recovery room.

During the Hours of Operation, one RN is assigned to the treatment room and one RN is assigned to the recovery room.

Additional personnel supporting the RNs include an anesthesiologist, psychiatrists, Behavioral Health Technicians and Nursing Leadership.

All staffing levels are presented per shift and not intended to be at all times.
