Note: Facilities found to be in violation of the New York State Facilities Code pursuant to Section 12 of the Public Health Law may be liable for penalties of up to \$10,000 per violation of Article 28 of the Public Health Law. Under state law nursing homes can be fined up to \$2,000 per citation. These fines may be increased to \$5,000 if the same violation is repeated within twelve months and the violations were a serious threat to health and safety. These fines may also be increased up to \$10,000 if the violation directly results in serious physical harm.
