Guarantee that the Test Kits supplied by the Vendor are authorized by the United States Food and Drug Administration's (FDA) Emergency Use Authorization (EUA) for Antigen Diagnostic Testing for SARS CoV-2 and 2. Guarantee the Test Kits supplied by the Vendor are authorized by FDA for Over the Counter (OTC), Home testing, Serial Screening, Single Target use. Please clarify Serial Screening requirements	The FDA EUA Antigen Diagnostic Testing for SARS CoV-2 must include the attribute of serial screening. Serial testing involves testing the same individual multiple times within a few days.
