

# Suggested SADC Site Evaluation Tool and Guide Updates for SADC PCSPs

### Good morning,

The New York State (NYS) Department of Health (DOH) would like to notify MLTC plans that the Suggested Social Adult Day Care (SADC) Site Evaluation Tool and corresponding guide have been updated and the most current versions (5/31/2023) have been added to the NYS DOH MLTC website (MLTC Policy Documents).

The Suggested SADC Site Evaluation Tool and guide have been developed as a resource to assist MLTC plans in oversight of SADC compliance with State and Federal requirements. The most recent updates provide resources to evaluate compliance with SADC Person-Centered Service Plan (PCSP) template requirements. These requirements help ensure accurate member demographic and medical information is collected, and that member preferences, methods for community integration, and needs/goals are meaningfully represented within their SADC PCSP.

There was also a small update to include two questions on ensuring the SADC has registered with New York City (NYC) Aging, if the contracted SADC site is located within the 5 boroughs. The updated user guide also contains details, based on guidance from the Centers for Medicare and Medicaid Services (CMS), on what is and is not community integration.
