### **Enacted Budget: Standing Order**

- The standing order was issued on June 10, 2024
- Medicaid members no longer need an individual recommendation/order from a healthcare provider for doula services to be covered by Medicaid and doulas do not need to keep a copy of an individual recommendation/order for services rendered on or after June 10, 2024.
- The standing order was authorized for one year and would need to be reissued with each successive Commissioner of Health.

- The Medicaid Doula Services provider manual will be updated accordingly to reflect the change in requirement and refer to the standing order.



### **Medicaid Managed Care Carve-Out Information**

- Doula services will be carved out of the Medicaid Managed Care (MMC) plan benefit packages between March 1, 2024 and September 30, 2024.
- <u>All Medicaid Members who are enrolled in FFS or MMC plans are eligible for Medicaid coverage of doula services during and after the MMC carve out.</u>
- Doulas must first enroll in Medicaid as FFS providers before they can contract with MMC Plans

- Each MMC Plan will have their own contracting process for doulas.
