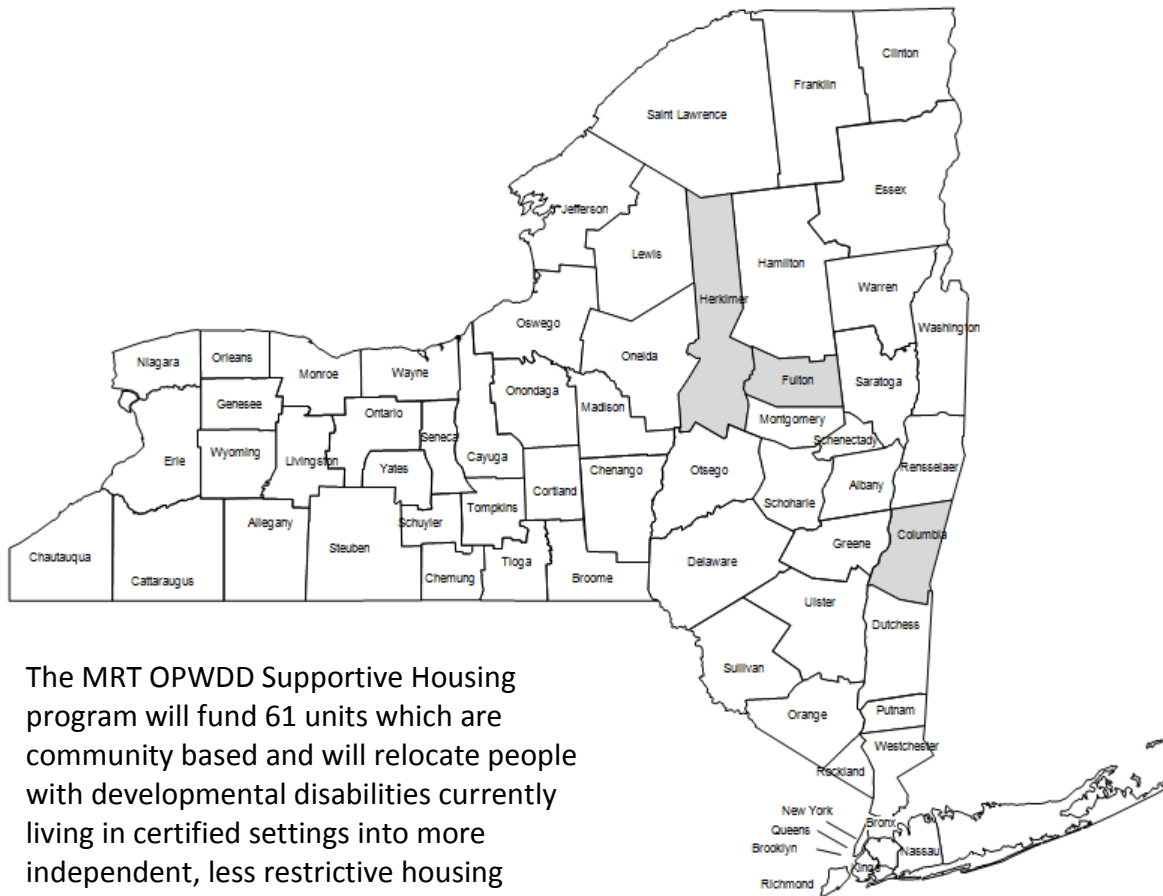


OPWDD Supportive Housing - MRT Beds in Capital District & Mohawk Valley

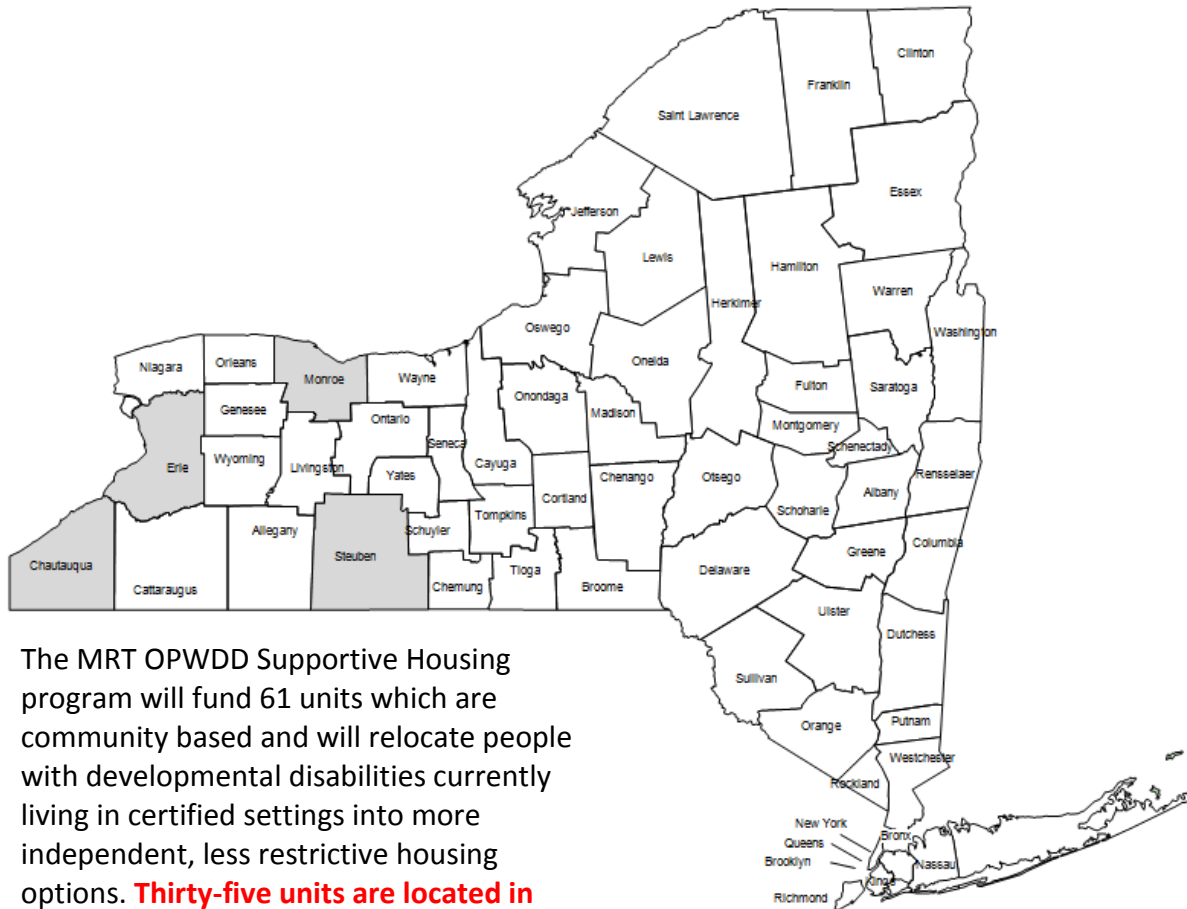

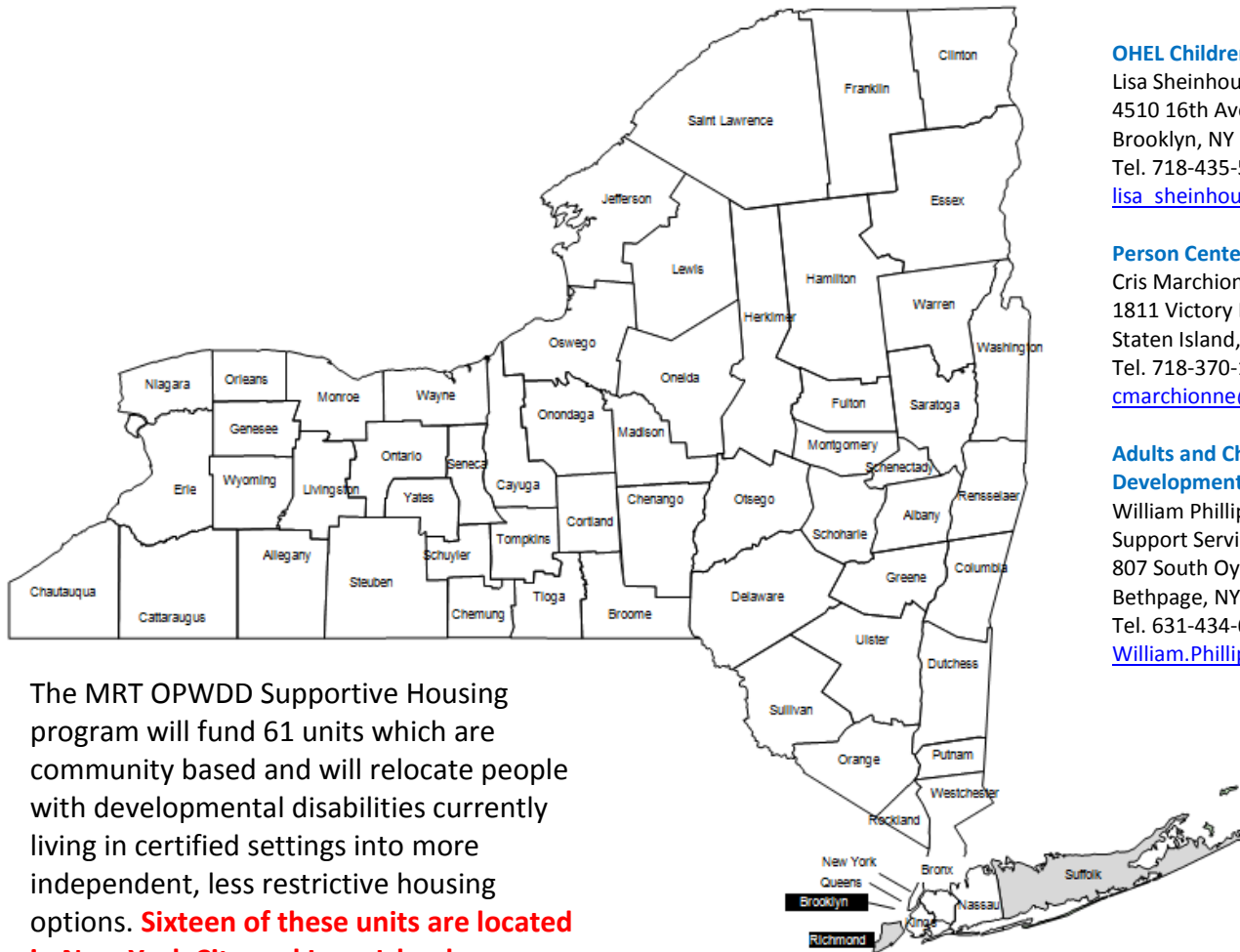
