#### Payment Year 2014 and 2014 Edition Certified EHR Technology

Please be aware that CMS Meaningful Use Stage 2 Final Rule now requires EPs attesting to Payment Year 2014 of the NY Medicaid EHR Incentive Program to acquire a 2014-Edition Certified EHR Technology to meet the Adopt, Implement or Upgrade (A/I/U) requirement or demonstrate being a Meaningful EHR User.

- Providers must update their Payment Year 2014 attestation in MEIPASS to only include a valid 2014-Edition EHR Certification Number(s).
- Attestations that do not include a 2014-Edition EHR Certification Number(s) in

Payment Year 2014 will be rejected resulting in delays and rework on the providers' behalf.
