Public Health Reporting - September 9, 2020 at 11:00am

This webinar will provide an in-depth review of the Meaningful Use (MU) Stage 3 Public Health and Clinical Data Registry Reporting Objective, including the requirements of the Objective and how to successfully meet the criteria needed to attest.

Health Information Exchange – September 17, 2020 at 11:00am

Health information exchange (HIE) allows providers and patients to share data electronically, making sure that providers have access to the most accurate and up-to-date information about patients' health and treatment history. This webinar will define what HIE is and will review terminology and concepts to help you better understand this Meaningful Use Objective.

This discussion will focus on the PY2020 Soft Opening and how providers can utilize this attestation option.
